

## NAACP OF BUCKS COUNTY PA IGNORES POLICE CORRUPTION

In mid 2025, while I was in prison again for 8 months for another technical parole violation (this time sending letters to lawyers looking for a lawyer to sue jaskowiak and others) of the false charges of 2 counts of harassment, I sent a packet of documents, pictures and explanations why the cops arrested on me to the NAACP hoping they would help me. The packet explained I had only been protesting on a public sidewalk, in silence, in front of jaskowiak's house. The charges were made up only for the purpose of helping corrupt lawyer jaskowiak put me into prison. Jaskowiak had put me into prison two other times for exposing the guardianship scam on Mother by jasko rat and others, including corrupt judges, corrupt guardians, corrupt lawyers, sister jsh and others.

NAACP NEVER responded. I thought they told everybody they cared about police corruption and driving while black. BS!

Dear Director of Bucks County NAACP,

I am in men's center, Bucks County Correctional Facility, minimum security, e14. I am 72 years old. I was arrested on April 23<sup>rd</sup>, 2024 by the police of New Britain Township for protesting on a public sidewalk, in front of a lawyer's house. This lawyer, among many others, were stealing hundreds of thousands of dollars from my mother, 96, while she had been forced to exist in a low-rated nursing home in Chester County. Mother was a victim of a false guardianship. Guardianship corruption is massive nationwide and it only to get the victims money and assets. The criminals include corrupt judges, guardians, lawyers, psychologists, and others. Mother was forced to live in solitary confinement, in a sensory deprived environment, no phone, not allowed into society or even to visit her home and her much moved possessions of almost 100 years. My visits with mother were basically eliminated as a punishment for constantly fighting for mother to get mother back home. Mother and I always had an extremely close and loving relationship. Mother never had any mental or behavior issues, no medical issues and no financial issues.

Mother was finally killed by this "guardian mafia" on July 2<sup>nd</sup>, 2024 with morphine that kept her unconscious. Mother died a slow, painful, barbaric death of starvation and dehydration. I was exposing the corrupt lawyer who was assigned to mother by a corrupt judge. The lawyer had me arrested again on May 23<sup>rd</sup>, 2025 for sending letters to lawyers looking for a lawyer to sue. My arrest last year was based only on a false affidavit by the arresting officer, Officer Komatick, containing many lies, but also confirmed he knew why I was protesting. Both the cop and the lawyer, Jaskowiak, signed onto the fake affidavit. Enclosed are pictures proving the cop lied about what was on my sign and what I wrote on the sidewalk. I even videotaped much of those two hours of protest on April 23<sup>rd</sup>, 2024. I have a lawyer, but he is not a defense lawyer, just a basic lawyer of trusts, wills, etc. My sentence recently for sending letters to lawyers is 6-12 months. I need a lawyer to get me out now and sue the arresting officer, police chief, New Britain Township police department, New Britain Township itself, and Bucks County for false arrest, false imprisonment. The affidavit was a fraud and both the cop and lawyer committed perjury many times in court. I made a massive website [www.janeherring.net](http://www.janeherring.net) that has many documents, court documents, emails, pictures, et cetera, proving the false arrest on me and the guardianship scam on my mother. I have sent the same packets of pictures and documents to the police chief, DA Schorn 3 times, Christine Shenk who is head of the parole department who filed the recent demand for my arrest, and New Britain township supervisors, but NO response from any of them, including a meeting with the chief. How many other false arrests were made by this officer and New Britain Township police that were covered up? I need the help of the NAACP.

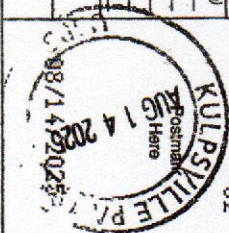
