

LOGIES LAWYER, ZABOWSKI, TRIES TO PAINT HIM AS A SAINT AS A GUARDIAN. BUT FACTS PROVE HE WAS ONLY A BARBARIC AND VICIOUS ANIMAL STEALING FROM MOTHER AND IGNORING HER HEALTH, WELFARE AND HAPPINESS AS MOTHER'S GUARDIAN OF PERSON AND ESTATE

Dwayne logie was appointed to be Mother's guardian of person and estate by corrupt judge weilheimer on August 6 2021. Logie never came close to caring for Mother's health, welfare and for her happiness. Logie was nominated by shister jaskowiak, a close friend who nominated/used logie to other victims many times because jaskowiak knew logie was just like the rest of the vicious animals of the guardian mafia who only wanted to steal the victims money and homes. These vicious animals were just like any of the other criminals who see men, women or children as THEIR personal property to use and abuse in any way those criminals wanted to use them, including raping and killing them for the criminals pleasure.

I used every means possible to expose logie and the other guardians gross incompetence and neglect of Mother of Mother's 3 year ownership by this mafia. Logie's only idea of being a guardian was to steal as much money as possible from Mother and to deny Mother the health, welfare and the happy life she had before Mother's daughter, jsh, filed the fake petition for guardianship just to get control of Mother's vast assets. Logie and jsh became best friends for their love of other people's money and by getting it using any dirty and disgusting way possible.

Finally, in May of 2022, logie quit as both guardian of person and estate. Replacing him would be 2 more of the worst animals, appointed by judge weilheimer, to be guardian of person and estate to Mother: pam blumer, ronald fenstermacher and later Cynthia ellis. After being appointed, pam blumer hired her husband/lawyer bill, who then hired several lawyers from his law firm. All of them charged Mother for their massive "legal" billing hours representing pam blumer. WTF? Both pam and bill blumer are close friends of jaskowiak and jaswiak nominated pam blumer knowing how it would benefit the mafia making more money, at Mother's expense. Neither blumer or any of the other guardians had the power to hire who they wanted, buy whatever they wanted and charge it to Mother. The fact is, I found out after pam blumer was appointed she had lied by claiming she was a certified guardian. She never was and still is not. Nobody cared she had lied about that major title.

Logies shister, zabowski, (who is well known with her connections to guardian corruption) filed logie/her reply to my petition to remove logie. Zabowski tried to insult me as much as possible to cover up the fact that logie was just a maggot on Mother for her money. Logie claimed in his bio he was/had been a guardian to 115 other people (victims) and when he was appointed, he had 13 "victims". I would pay to get a list of those victims to confirm logie was as much of a maggot and criminal to those innocent people as any of the people I

met while in prison after jaskowiak sent me to prison 5 times for exposing the scam on Mother by the guardian mafia. How many of those victims was logie also a guardian of estate dealing/stealing their money?

Zabowski and the others in the guardian mafia NEVER used facts in their arguments in their petitions. They used only childish insults and lies about me to divert the attention away from them being just common barbaric, inhumane animals.

There are many examples in zabowski's reply of her lies and insults about me. Zabowski mentions Klock. Klock is well known for stealing and over drugging her victims. Klock is not a certified guardian. Why did logie hire klock as a "care manager"? According to klock's website, she does the same thing as logie. Z (Zabowski) mentioned I refused to give Mother a covid vax. That was Mother's choice before the fake petition was ever filed by jsh. We know now those vax's were not effective and also extremely dangerous. Why did logie put Mother into that pig pen nursing home when it had just re-opened after many months of being shut down because it was covid infected? Why didn't he put Mother back to her safe home? According to studies, about 39% of the people that died of covid, died in nursing homes. WTF, logie? Pam blumer and later Cynthia ellis also kept Mother in that covid infested pig pen.

Z claims logie removed Mother from her home because I had not been treating Mother as a loving and caring son. Z claimed logie /sister kidnapped Mother from her house because I was also acting in my best interests, not Mother's. WHO was making all of that money stealing from Mother? Only the guardian mafia, including logie and Z. Mother had NO problems with her happiness, health, welfare, medical or financial matters during Mothers 8 years after her husband died and the 2 years while I was living with Mother at her request before the fake petition was filed by sister/lawyer camp. Not one example of any problems were given in camp's fake petition, not one example of any problem was ever cited in court for THREE years that Mother had any problems and NO ONE was ever brought in during the petition hearing to say Mother ever had any problems. Z claimed ledakis said Mother could live at home and everything was fine because I was there for 2 years only because ledakis did not know everything that I had done wrong to Mother. Really? Ledakis had TOTAL access to ALL of Mother's medical, ALL of Mother's financial records AND to ALL of the people Mother dealt with every year. How come ledakis NEVER found any problems about me from any of those people Mother dealt with every year, including her banking and investment people? Because there were NO problems that I was causing Mother. Because of my questioning during the petition hearing, Ledakis admitted he had NO proof that any of the "tests" he claimed he gave to Mother and his final "evaluation" had any proof of accuracy. Ledakis charged \$4500 for his scam. The mafia hired him many times because he always said lies about me to make more money and for the mafia to use to deny me visits.

Z goes on to claim that Mother was kidnapped and put into jsh's house because I was interfering with logie's job. BS! NO examples were ever cited that I interfered with logie. It was logie that refused to answer my questions about his ongoing plans for Mother and why he was ignoring problems I found pertaining to Mother's welfare and happiness. If Z and logie were so concerned about Mother's welfare, why did they lie about their claim that Mother fainted at jsh's house because it was a hot day and Mother was dehydrated.? The temperature was only about 80. Mother had to be taken unconscious, by ambulance, to the hospital, confined to bed for 6 WEEKS and treated for STARVATION. While in the hospital, Mother got covid where she could have died. Z and other's blamed me for Mother getting covid. But, I never got covid, so how could I have given covid to Mother? There is NO way a person who only misses one or two meals would pass out. How come NO person in the mafia ever mentioned jsh's gross mistreatment of Mother for that and that Mother had to be drugged at jsh. If Mother was so happy at jsh's house, as jsh had claimed in court, why did Mother have to be drugged constantly??

Z claimed logie could not find any place that wanted Mother. BS! I was constantly finding nursing homes that were much bigger, much nicer and much cheaper. But, none of the mafia wanted Mother to go to those places. WHY? Was the pig pen the only place giving kickbacks to the mafia? Z claimed I was screaming at Mother and she was happy at the pig pen. Really? If Mother was so happy at the pig pen, why was Mother on anti depressants all of the time? WHY was Mother kept in the same tiny room, in solitary confinement, in a sensory deprived environment, no phone, no TV, torn blankets, urine stained towels and sheets, dead mice in her room and never allowed outside into society or back home to see her much loved possessions of almost 100 years? Is that how the mafia and jsh thinks a 96 year old woman should be forced to live until she dies? WTF?

Z claims the extreme, extreme visit restrictions were correct because of the way I treated Mother. Really? It seems Z forgot the 6th amendment which deals with due process of law, that a person is presumed innocent until proven guilty in a court of law and the person has the right to face their accusers. WHERE was my trial by the mafia for anyone to PROVE their accusations against me? Never happened! WHY? The fact is, I finally filed my petition in September 2023 with judge sterling (took over from weilheimer) for the mafia to prove in a court of law that I was doing the things against Mother they claimed. ALL of the lawyers begged sterling to deny my petition and she did. WTF?

Z claims the mafia offered to gift me money to move out of Mother's house, but I refused. LIE! They never did. They wanted me out only so they could sell Mother's house which was a 3 bedroom, 3 bath house in a gated community, built new 22 years ago and worth about \$500,000 only to add more money to their bank accounts. Mother had put it in writing long before the fake petition was filed that she wanted me to live in the house, whether she

was living there or not. WHY would the mafia want to keep Mother locked in solitary confinement with people with mental and behavior problems when NOBODY ever claimed Mother had those problems? WHY would the mafia think Mother would be happy in a tiny room until she died with old and broken furniture, instead of her huge house she lived in for 22 years? Would any of the mafia want to live like they were keeping Mother as a prisoner?

Z claims logie was doing such a great job for Mother as guardian of person and estate. BS! Then why did he want to quit and lose all of that money he and Z were making off of Mother?? Because I was constantly exposing him and the mafia as only crooks and thieves and ignoring all of the problems that only I was finding that affected Mother's health, welfare and happiness. In addition, while at the pig pen, Mother got covid 2 more times at 97 and 98 where she could have died. She injured herself because she fell several times (my pictures do not lie) because the floors were slippery when waxed. I kept buying her no slip socks, but the staff kept stealing them. After logie put Mother into the pig pen, he canceled her medical alert necklace. Why? There were no cameras in the halls and the staff was usually never around. If mother fell or had a stroke or heart attack during the night, no one would know she fell or was dying. WTF? Logie/mafia kept claiming Mother's swollen legs were caused by the food I was formally allowed to bring her for our few lunches. But, Mother had NO food allergies and NO diet restrictions. What types of fried and other types of high salt food was the pig pen feeding Mother that really caused her legs to stay swollen after I stopped giving fresh food from home?

For 3 years I tried every way to get Mother home and away from those sick animals, but no success. Those measures included filing petitions to remove the guardians, fire their lawyers, demanding the corrupt judges weilheimer and sterling recuse themselves, filing complaints with the lawyer and judicial conduct boards to disbar the judges and lawyers, remove jaskowiak as Mother's lawyer, remove a "care manager" klock and remove the quack psychologist ledakis. Court transcripts, documents, emails and pictures on my news website janeherring.net prove those involved in Mother's fake guardianship never cared for her health, welfare and happiness, only wanted Mother's money.

**ANSWER TO PETITION FOR
REVIEW AND REQUEST TO REMOVE GUARDIAN**

Dwayne Logie, Permanent Plenary Guardian of Person and Estate, files the following

Answer and respectfully represents:

1. Admitted.
2. Admitted.
3. Denied. The averments contained within paragraph 3 and subparagraphs (a) through (k) are specifically denied. Strict proof is demanded at the time of hearing.
 - a. Denied. Strict proof is demanded at the time of hearing. On the contrary, Mr. Logie has acted appropriately by initially contacting Jane Herring's long time primary care physician, Dr. Kuhar, communicating with her and obtaining guidance. Further, Mr. Logie has consulted with Deborah Klock, a Registered Nurse and Certified Geriatric Care Manager, to obtain guidance and assistance. In addition, Mr. Logie arranged for Jane Herring to receive a Covid vaccine which Arthur Herring refused to do.
 - b. Admitted in part; denied in part. Strict proof is demanded at the time of hearing. It is admitted that Mr. Logie removed Jane Herring from her home. This occurred because Arthur Herring prevented Mr. Logie from doing his job

and Mr. Logie determined, as Judge Gail A. Weilheimer did, that Arthur Herring was an inappropriate caretaker who acted in his own best interest and not that of his Mother. It is admitted that Mr. Logie sold Jane Herring's car since she is no longer able to drive. It is denied that this conduct deprived Arthur Herring of a valuable asset; Arthur Herring did not own this car and had no right or entitlement to the vehicle. The car was a liability for Jane Herring's estate. The issue is what is best for Jane Herring, not Arthur Herring.

- c. Denied. After reasonable investigation Mr. Logie is without sufficient information to form an opinion as to the truth or falsity of the averments contained with subparagraph C and strict proof thereof, if relevant, is demanded at the time of trial. By way of further answer, it is specifically denied that Jane Herring's placement at Manatawny Manor was against the report and opinion of Dr. Ledakis. Dr. Ledakis was not aware of the extent to which Arthur Herring interfered in Jane Herring's life. Mr. Logie acted after consultation with the appropriate medical personnel who are well aware of the most recent medical developments in Jane Herring's life. Jane Herring also needed to be removed from Arthur Herring's care since he refused to schedule an appointment for her to be vaccinated against Covid and he refused to be vaccinated himself, all of which put his mother at risk for her health.
- d. After reasonable investigation Mr. Logie is without sufficient information to form an opinion as to the truth or falsity of the averments contained with subparagraph D and strict proof, thereof if relevant, is demanded at the time of

trial. Mr. Logie was appointed at the conclusion of the guardianship hearing and cannot comment upon Dr. Ledakis's testimony. Further, it is contended that Arthur Herring has taken Dr. Ledakis's testimony out of context. The certified geriatric care manager and other relevant medical personnel recommended Jane Herring's current placement.

- e. Denied. Strict proof is demanded at the time of hearing. It is contended that Arthur Herring's hatred for his sister results in his vituperative comments towards her. Jane Herring was initially transferred to her daughter's home when it became clear that Arthur Herring was not an acceptable caretaker and acted to obstruct the guardian's ability to do his job. Jane Herring was hospitalized after she refused to eat or drink on a very hot, humid day during the summer. The hospital admitted her because she needed to be admitted to the hospital. The duration of her hospital stay was engendered by the following issues: (1) her presenting medical condition, (2) the fact that she contracted Covid after being visited by her un-vaccinated son, and (3) the challenge of finding an appropriate bed in a suitable care facility.
- f. Denied. Strict proof is demanded at the time of hearing. Jane Herring is residing at Manatawny Manor which is an appropriate care facility for her. When not subjected to the screaming by her son and his desire to control her every action, Jane Herring is happy and content in her new environment.
- g. The averments contained with subparagraph G are specifically denied. Strict proof is demanded at the time of hearing. After consultation with staff and the geriatric care manager, Ms. Klock, the visitation scheduled was proposed to

Judge Weilheimer who entered an appropriate order. Arthur Herring's controlling and inappropriate behavior are solely responsible for the visitation schedule which is in place.

- h. Denied. Strict proof is demanded at the time of hearing. Jane Herring has access to a telephone during reasonable hours of the day. It is contended that a private phone is not in the best interest of Jane Herring because Arthur Herring will use it to dominate and manipulate his Mother by constantly calling her and brainwashing her. Evidence of this behavior is that he will call ten (10) times a day to speak to his Mother. Staff at the facility have noticed agitation exhibited by Jane Herring after she has a telephone call with her son.
- i. Denied as stated. Strict proof is demanded at the time of hearing. It is admitted that Mr. Logie has given Arthur Herring notice to vacate his Mother's home and it is contended that Arthur Herring defiantly refuses to vacate the property. Further, Arthur Herring has refused to contribute financially to the maintenance of this home and is only concerned about the sale of this asset since he will then need to locate alternate housing. Despite our offers to gift Arthur Herring with sufficient funds to pay for his reasonable rental costs, he continues to engage in a pattern of behavior designed to threaten, intimidate, libel and harass any person who refuses to accede to his self-serving demands.
- j. Denied. Strict proof is demanded at the time of hearing. It is contended that none of the professionals in this case have been paid for their services. The guardian and all counsel are well aware that they must petition this Honorable

Court for payment for their services. Arthur Herring continues to engage in a pattern of lying for his own self-serving needs.

- k. Denied. Strict proof is demanded at the time of hearing. Mr. Logie responds to legitimate inquiries and refuses to respond to harassment.
4. Denied. Strict proof is demanded at the time of trial. It is specifically denied that Dwayne Logie has acted inappropriately or that he should be removed for cause. Mr. Logie is ready, willing and able to resign as Plenary Guardian of the Person and Estate of Jane Herring once appropriate successor plenary guardians of Person and Estate are appointed.
