She could not believe her own daughter would do such a dispicable thing to her mother, especially after my mother has been giving her \$14,000 a year, tax free for almost 9 years. I saw that my sister had signed those papers on May 17, the same day she took my mother out to lunch, the day after my mother's birthday. She had not even mentioned to my mother about any possible reasons for filing those papers. I had also told you my sister has mental problems and has written emails to almost everyone my mother knows and does business with telling them my mother is crazy and other types of lies. Dr. Kuhar had told my mother and myself last year my sister has a "personality disorder".

My mother, as well as I, was extremely disturbed of your conclusion about my mother's condition, with only a hour's interview. No test, whether written or oral and in an hour, can come up with a conclusion that someone is mentally unable to make decisions for themselves and must have a person make life decisions for them. Dear Dr. Carroll,

I asked you previously several times, did you audio record my mother's meeting with you? You have not responded.

I read your report and was extremely disappointed, to put it lightly. You claim your "conclusions" were made with a "reasonable degree of scientific certainty". What is that number? Scientific? What was "scientific" about using a couple of paper and pencil tests and asking a few general questions? There are many hundreds, if not thousands, of paper and pencil tests, including for lie detection, on the internet for psychological evaluations and employment screening, such as the 600 question MMPI. What is the accuracy of them that has been independently proven? Basically, no accuracy better than a coin toss. For the record, you never did any medical tests.

The instrument is called the PSE. My clients included law enforcement, private businesses and mental health types.
