

## LARRY WEILHEIMER, VP AND CHIEF LEGAL COUNCIL PHILADELPHIA INQUIRER

Corrupt lawyer larry weilheimer has always killed all stories by his Inquirer reporters dealing with the massive corruption of judges in the orphans court of Montgomery county. Larry did that because his corrupt wife, gail, was also a judge in the same orphans court for about 10 years. Gail is best friends of lorie Shapiro, wife of governor josh shapiro. Josh nominated gail to be a US district court judge to biden and biden appointed her in about mid 2023.

Corrupt judge gail was the main judge on this fake, money grabbing guardianship scam on my now late, very much loved Mother, Jane, starting in May 2021. My former sister, jsh (age 70 at the time), filed the petition for guardianship on her Mother to be both guardian (also known as owner) of person and guardian of estate to own all of Mother's vast assets, including her huge house in a gated community. Jsh dropped out at the beginning of the petition hearing to be both guardians because I was going to expose how jsh and Mother's trust lawyer of about 22 years, Ronald fenstermacher, had been trying to steal money from Mother without telling Mother. A year before, jsh and fenstermacher tried to do a fake "guardianship" of Mother without using the courts. I stopped all of those money grabbing plans by them. Mother fired fenstermacher about summer of 2020 and got a new lawyer to rewrite her Will, trusts, etc. Jsh had always hated her Mother and me all of jsh's life for unknown reasons. By my questioning during the petition hearing, Jsh admitted in court that she never even discussed her future ownership of her Mother with Mother before she filed the petition. When asked why in court, jsh said she did not think the matter was that important. WTF?

The transcript of both days of the petition hearing are posted on this site to prove what happened.

Corrupt judge gail was very deeply involved and always seemed to be in charge of the guardian mafia's money grabbing scam on Mother. Judge gail became a part "owner" of my Mother from May 18 2021 when the petition was filed by jsh/lawyer camp until about mid 2023 when judge gail became a US judge. Judge gail owned Mother just like a pimp owns his girls. The pimp calls those girls HIS merchandise. Mother was going to be just disposable cargo for this mafia. During her time as part owner of Mother, gail committed many felonies against me and allowed two fake contempt of court charges to be used against me because I was revealing information about the scam in various ways. Those fake contempt of court charges were filed by cry baby jaskowiak. Jaskowiak was appointed by gail only 3 days after the petition was filed by jsh/camp. But, camp sent me her email, with the petition, only May 24. WTF? Mother and I were given NO time to find our own lawyer. Why? Because judge gail

wanted to be sure she/guardian mafia had one their own controlling what happened with Mother. The mafia made sure Mother was always kept in the dark and NEVER knew her rights under the law and what the mafia was doing to me. For example, in June 2023, gail sent me a letter telling me she was having the county IT person, Olivieri, block my email address to her office. She claimed she was annoyed that I was contacting her office asking for information about procedures because I was pro se. But, gail totally lied. She told Olivieri to actually block my email address to ALL county agencies, including the DA office, board of commissioners and the sheriff. I have a copy of both the letter by gail and the email Olivieri sent to gail's secretary. They are posted on my news website [janeherring.net](http://janeherring.net). Gail was trying to stop me from using those county agencies to help my Mother get back home from Mother's tiny, low rated, pig pen at the nursing home she was put in by gail's first guardian of person and estate, Dwayne logie and jsh. Mother had to live in her cage until she was killed/died by the mafia on July 2 2024 in a very painful, barbaric and inhumane way.

Mother's shister, "Cry baby" jaskowiak stayed glued to Mother until Mother was killed/died on July 2 2021. Cry baby made a video about guardianships for lawyers in October 2019. Cry baby bragged in his video he uses contempt of court petitions, with the threat of prison to the other side to get his way in a trial and to make money. Cry baby even joked that prison is "3 hots, a cot and a date with Bubba". Bubba is the nickname of a fat, black man and a "date" in prison is male rape. Cry baby was making fun of men getting raped in prison. Sick! Plus, using the court as a weapon is called lawfare and is not allowed by any honest judge. But, with corrupt judges like judge gail and sterling, anything is alright if it makes them money. Screw the AIP (alleged incapacitated persons) was always the shister's motto and all of the others connected with this scam. Cry baby filed two contempt orders on me with gail and won both times because I was revealing information about the scam on Mother on my news website [protectmyparents.us](http://protectmyparents.us). But, Mother, even as AIP, still has many rights, including making decisions for herself and what she wanted. Mother always told me I could release any information about her I wanted. The mafia had NO justification for filing those contempt charges. At another time, cry baby threatened me with contempt of court because I had set up a Go Fund Me account to raise money so I could hire a lawyer. He claimed I would be violating Mother's right of privacy. I never used her name or where she lived. More attempts by this mafia to keep control of Mother. Cry baby filed a third on me with sterling, but I won. Cry baby even charged Mother to do that one, just like he charged Mother about \$5,000 each time for the first two contempts he did against me. What was gail's cut of cry baby's charges to Mother for those those contempts of court he made. Both cry baby and the other shisters tried to get DA steele to file wire tapping charges on me, claiming I videotaped Mother without THEIR approval. Nothing happened with that, except they all charged Mother for their time trying to do so. The shisters, including cry baby and fenstermacher (guardian of estate) had me evicted from Mother's house without asking her in August 2023. I had to live in my car, summer and

winter, for 2.5 years. But, I had a written note from Mother she wrote several years earlier, signed and dated to fenstermacher saying she wanted me to always live in her house, whether she was there or not. Both times, gail put me into prison for those contempts by jaskowiak. The first time she said prison would be 6 months or until I deleted the information on my site. There are no computers in prison. That was a joke to the mafia. The mafia thought they could get rid of me for 6 months. But my IT person was able to get it deleted and I only spent about 2 weeks in prison. Instead of the information on my site, I put a link on my site to Google's Wayback machine which archives all websites for the past 30 years. In the second contempt by cry baby with gail, cry baby claimed a link was the same thing as posting the information. Gail agreed, but she lied. She said in her order if I paid jaskowiak his \$4,600 fee to create the contempt, that would be my penalty. But as always, gail lied. It was supposed to be only a civil contempt and a fine. But, gail also put me into prison until I got Google to delete the link and its information exposing the scam on Mother. Prison can ONLY be given in a criminal contempt. In a criminal contempt, I could have a jury trial and a free public defender. I was in prison for about a month because my IT person could not get Google to remove the link and information. Google believes in free speech. By late 2022, I was on welfare because I almost no money left because of earlier lawyer costs and other costs to get mother home.

Judge gail issued many orders that proved she wanted to cover up and protect the illegal and barbaric crimes of the mafia on Mother only to keep getting Mother's money money. For example, she ordered I could not tell Mother they evicted me from her home, nothing about the scam on her and that I had been in prison. No free speech? Clear violation of the constitution. Did NONE of those shisters know about the constitution, free speech and freedom of the press? The mafia was afraid that if Mother found out about them and what they were doing to her, Mother would use her rights to get home and away from their claws.

This "mafia", besides the two corrupt judges gail and sterling on Mother's case, also included corrupt guardians Dwayne Logie, pam blumer, Ronald fenstermacher, Cynthia Ellis, corrupt lawyers "cry baby" jaskowiak, diane zabowski, bill blumer (pam's husband), jsh's lawyer britanny camp, thad gelsinger and other lawyers bill and thad hired from their law firm only to create tons of billing hours paid by Mother, jsh, a very corrupt "care manager" deb klock who has a long history of stealing and over drugging her victims, corrupt quack george ledakis and the 2 paid liars (monitors) hired by pam blumer to "sit" with Mother and I during our few visits together only to make up lies about me for the mafia to dent visits with Mother and to charge me money for the mafia. Pam blumer even lied whne she became a guardian of person to mother. Blumer claimed she was a certified guardian. But, I found out several months later she lied and my proof is posted on this site. That is called fraud. She hired her husband bill as her lawyer the day she was hired. That is a conflict of interest. Both were billing Mother for their time. Most of the others were also hiring people and charging Mother.

Wrong! If they wanted to hire people as part of their business, then they pay them from the profits of having a business.

This guardian mafia kept Mother locked in a low rated nursing home, in solitary confinement, in a psycho type section with people with mental and behavior problems, with men, no locks on the door, no cameras to see who was going into a womans room, kept in a sensory deprived environment, NO phone or TV, dead rats in her room, torn blankets, urine stained towels and sheets, other people's clothes instead of her own, covid infested. Mother got covid twice there. According to studies, about 39% of people who died from covid, died in nursing homes. Those corrupt guardians did not care to put Mother back home to be safe, happy and healthy. After my father died in 2013, there was a spare bedroom and bath for any health workers to have, even overnight to care for Mother, IF she ever needed it. Mother was not allowed to see her own doctors. By definition of being "incapacitated" by the mafia, Mother still had many types of rights, including federal rights by the ADA, state rights, nursing home rights, rules that the AIP have that must be followed by any guardians. For example, the Olmsted Act says any person with a disability CANNOT be institutionalized, they must be kept integrated into society. But, the mafia never allowed Mother outside into society, never allowed Mother to go back to visit her home of 22 years and with her much loved possessions of almost 100 years. Gail/mafia only gave me very infrequent, extremely short, rare, 1 hour visits with Mother. Why? Those few visits were either totally denied for months or severely restricted as punishment because I was constantly exposing this mafia scam of Mother on my other news website protectmyparents.us. I was using a fake name for her and myself. I was also protesting in front of the court house with the names of gail, sterling or DA steele on my protest signs and I was on many radio shows talking about the scam. Even the FBI refused to open a case on Mother and many other victims of this mafia and other corrupt guardians stealing their victims money. The FBI called them civil matters, not criminal. BS! Look at the Gloria Byers article on this site. The FBI DID prosecute and CONVICT Byers for guardian corruption for stealing over \$1 million from her 105 victims. Byers died just before sentencing. Because of my severe frustration with the FBI, twice I put signs at their door telling them to investigate. I took pictures of it. What did the FBI do? They sent me a email telling me if I did it again, they would arrest me for trespassing. WTF feds?

The fact was, Mother NEVER was accused by anyone of having any mental or behavior problems to be kept as a prisoner in that psycho ward at the nursing home. Mother was drugged and fell many times because of the drugs. Mother hurt herself, sometimes badly. I have pictures posted. Mother NEVER had any mental or behavior problems. It was jsh that had mental and behavior problems and some of her answers in court proved them. Mother had NO financial, NO medical and NO personal problems where she needed a guardian of any type. NO problems were ever cited by jsh/camp in the petition written by jsh's corrupt lawyer, Camp. Plus, NO persons that Mother dealt with, every year (primary doctor of 21 years, other

doctors, investment people, dentist, CPA, house keeper, hair dresser, etc) were ever brought in to testify Mother had any problems. Camp has a lot of training in guardianship. Then why did camp NEVER include any problems or bring in anyone to claim Mother had problems? Because Mother had NO problems. So, WHY did gail and/or "cry baby" jaskowiak NEVER demand the petition be denied for lack of evidence? Because this mafia WANTED Mother to be guardianized for Mother's vast assets for THEM to steal. Mother was still driving her car safely at age 96. But, NO person, not even their quack psychologist ledakis they hired to say Mother was 100% "incapacitated" to get Mother's money, EVER tried to or wanted to explain how Mother could be 100% "incapacitated", but still have ALL of her logic, reasoning and common sense to safely drive a car without any tickets or accidents for over 50 years. Not even her primary doctor of 21 years ever said Mother should stop driving. I made it a habit of letting Mother drive so many times so I could see if she should ever stop driving after my father died in 2013. The quack Ledakis admitted in court during the petition hearing, ONLY by my questioning, that NONE of his "tests" he claimed he gave Mother in his only 2, 1 hour sessions with Mother or his final "evaluation", had any independently proven accuracy. Ledakis even admitted, by my questioning, that he never audio or video taped his claimed sessions with Mother to prove what she said or did not say and how she said any statements, especially since it involved a court of law and Mother's life and welfare. But, Ledakis claimed on his website that his sessions last about 3-6 hours and he wants the family to attend them. BUT, I was BANNED from being there during those sessions by the mafia. Why? Several times cry baby came to the house to talk to Mother before the petition hearing. He refused to let me be in any of those meetings. He NEVER left any notes for Mother and I to discuss of those meetings, especially since the meetings were in lawyer talk and clearly neither Mother or I knew anything about law and in this guardianship matter. Ledakis claimed in his "evaluation" Mother had NO problems with her daily activities: eating, preparing meals, housekeeping, personal hygiene, etc. Ledakis also stated that because I had been living with Mother, at her request, for 2 years, everything was fine and Mother would have NO problems coming to court to testify. So, WHY did ledakis claim Mother was 100% "incapacitated" and needed both guardian of person AND estate when Mother had NO personal or financial problems? Because I had been living in Mother's house and knew her best in every way, the mafia refused to let me testify about her to destroy the mafia's attempt to claim Mother was 100% incapacitated. The mafia always REFUSED to let Mother come into court to testify for herself because they knew Mother could prove she was NOT "incapacitated" and would not need any guardianship. If that happened, no more money from mother for the mafia. Cry baby jaskowiak always wanted to be sure Mother never came into court, even if a subpoena was filed by a lawyer. Gail would always deny those subpoenas and she did with Mother. Mother had the LEGAL right to come into court all of the time. Ledakis was hired by the mafia many times to have other meetings with Mother for the mafia because he always said what they wanted to hear and to use against me to restrict/deny visits with Mother. FYI. Judges and lawyers call

psychologists and psychiatrists the "Whores of the court" because those quacks will always say what they are paid to say in court by lawyers to help their clients.

Cry baby loved using the court as a weapon, his personal weapon on anyone who got in his way. I found out where cry baby lived in New Britain. On April 10 2024, I found out where cry baby lived. I passed out a 2 page news letter to his neighbors, that was posted on my news website protectmyparents.us, about him and the mafia scam on Mother. On April 24 2024 I wrote a 3 word message on the side walk in front of cry baby's house and I protested with a sign. Within minutes, a neighbor, Harmon, who claimed he was a PA state cop, told me the sidewalk was private property and he would arrest me if I did not leave. I did not believe him but I left. I went to New Britain PD and spoke with a code enforcement officer. He said the sidewalks were public property and I could protest on them. As I was leaving, I met the cop Komatick. He was called by cry baby because of me protesting and exposing him as a crook.. I spent about 20 minutes explaining to komatick why I was protesting and jaskowiak's involvement. I gave komatick my card with my news website and I left. On April 27 2024, at 9am, I went back to protest in front of cry baby's house knowing it was legal. The police were called by cry baby almost as soon as I got there. One of the two cops was komatick. I videotaped my entire 2 hours protesting in silence. The video, in full, is posted on this site. At NO time did komatick or the other cop tell me I was doing anything illegal. At 11am, komatick arrested me. Both komatick and cry baby were on their cell phones for almost the 2 hours I was protesting. Who were they talking to? What were they arranging? What did their body cameras and their car mounted cameras show. Were they on? I doubt it. If not, why not? Cry baby and the cops were trying to make a simple protest into a major crime to arrest me so I would be put into prison for cry baby because of me exposing the scam and his involvement in it. Cry baby is a known lawyer in Bucks county and is about 70 years old. The charges were 2 counts of harassment. All of those legal papers of my arrest and the false affidavit by Komatick are posted on this site. Luckily for me, komatick lied a lot in his affidavit. I have pictures of and explanations to prove he lied. At trial, my public defender refused to let me testify or use my documents to prove the dirty cop, Komatick lied. Both jaskowiak and komatick swore under oath the cops affidavit was true and correct. That is called perjury and giving a false affidavit to law enforcement are also serious criminal offenses. I was convicted on both counts. At trial for 2 counts of harassment, the bail was \$100,000. I was put into prison. I had no such money. I had to wait 2 months to ask for a bail reduction. At that time, I told the bail department it was only a protest on a public sidewalk. They reduced the bail to \$10,000, or \$1,000 (10%) to get out and I posted it. I was found guilty and got 12 months probation. When I got out, I had to sign a document called a No Contact list of 11 rules. It listed things I could not do. Some of those restrictions are very vague. Several months after I got out, I found out that both jaskowiak and fenstermacher were deliberately sending time sensitive petitions to a wrong address knowing I would never see them, so decisions would go THEIR way. That is called

corruption. Because I was pro se, I sent both of them a email telling them I caught them trying to fix petitions. Jaskowiak contacted the DA and told him I contacted him (jaskowiak). I was put back into prison for breaking a very vague rule on the no contact list I signed. I had a hearing. I wanted to fight this so-called "parole violation", but my public defender told me if I pled guilty, I could go home today, but if I wanted to fight it, I would have to wait 6 months in prison for a trial. Bucks county public defenders are called "public pretenders" by the suspects because the public defenders always sell out the suspects to get them convicted to make the DA look like he is tough on crime. The public defenders meet the suspect only minutes before the trial. I decided to plead guilty and went home. About February 2025, I started sending out letters to lawyers looking for a lawyer to sue for my false arrest by the dirty cop komatick and jaskowiak. One of those letters was received by a lawyer who was a friend of jaskowiak and SHE sent my letter to jaskowiak. The envelope, with my letter, had the word "Confidential" in 1 inch high letters on the front. Plus, the privilege rule says any information sent to a lawyer is also confidential and the receiver must get the senders permission before releasing it. Cry baby went to the DA again and demanded I be tried and put back in prison because "indirectly" cry baby got my letter. WTF? At the trial, cry baby was allowed to give a "victims" speech. He lied 3 times in it. When jaskowiak finished his speech I told the judge, mchugh, jaskowiak lied and I wanted to prove it. Mchugh refused and claimed I could not be trusted. WTF? Neither the judge, prosecutor or my own parole officer, standing next to me, wanted to know how jaskowiak lied to the court? WTF? Jaskowiak is a lawyer and a officer of the court. Why didn't a judge want to know how jaskowiak lied? Why didn't the prosecutor mccartney? The receiver of my letter was not in court to be questioned by me. Therefor, the letter and envelope are called "here se" and NOT admissible in court as evidence. But, I was convicted anyway and sentenced to 6-12 months in prison. I served 8 and got out in January 2026. The rest of my parole ended in mid may 2026. While I was in prison, I had a friend send out packets of documents and pictures of the fake affidavit, why it was fake, my protest sign and what I wrote on the sidewalk. They were sent certified mail to many people. They were sent to judge mchugh, prosecutor mccartney, then DA schorn (3x), new DA khan in early 2026, the parole department, chief of police clowser of new Britain and each of the board of supervisors of new Britain. NONE of them ever responded or cared, especially clowser, that I was sitting in prison on a false arrest by one of his cops. WTF?

Gail hated me very much and based on her hate of me (no reason except I was exposing her/mafia's scam on many people LOL), according to the rules, she had to recuse herself. She never did to protect the scam. Those rules are posted on this site. She actually said in court that even if Mother went home, Arthur could not live there. Why? I was NEVER charged or convicted of doing ANYTHING bad to Mother. I even agreed to leave if Mother came home and I would get an apartment. But gail did not care to let Mother go back home to be safe and happy. Again, the mafia refused to ever bring Mother into court because they KNEW Mother

knew what she would be saying with logic and intelligence. Do lawyers and judges KNOW the law about punishing people WITHOUT a trial and conviction? WTF?

When jsh and logie kidnapped Mother from her house in August 25 2021, I was there. First guardian of person and estate was a crook named Dwayne logie. Logie is good friends of jaskowiak. He was appointed by judge gail. No reason was ever given. Logie had the police there to keep me outside as this kidnapping was going on. I heard Mother cry "I don't want to go several times as she was being dragged away by jsh. She was going to be kept at jsh's house for unknown reasons. The first day, jsh put mother on drugs to keep mother quiet. I called the police to do a wellness check on Mother because I was scared for Mother's wellbeing. The cop only went to the door and saw Mother standing at the window. He never talked to her. He called me later to say she was fine. WTF? The cops did not care about the health and welfare of a 96 year old woman? WTF? Jsh could have been standing next to Mother with a knife. The next day, I called the police again for another welfare check. They refused to do it. The next day, camp called judge gail because of me trying to get wellness checks on Mother. Gail actually told me if I called for another welfare check, gail would charge me with contempt of court and put me in prison. About 8 days later, I get an email from logie. He said because it was a hot day, Mother had fainted and was taken to the hospital by ambulance. I was not allowed to see mother for 2 weeks. No reason given by logie. The FACTS were Mother had fainted because jsh was not feeding her. Mother was confined to bed in the hospital for 6 weeks and treated for starvation, NOT dehydration, according to the doctors. Every day Mother had to have blood tests, Her arms were black and blue from those blood tests. Mother also had to get needles in her stomach every day to prevent blood clots. A 96 year old woman had to get painful needles in her stomach every day, for 6 weeks: 42 times. WTF? While in the hospital, Mother got covid and could have died. After 6 weeks, logie dumped mother into her pig pen, manatwany manor, near Pottstown. It was about an hour away from Souderton where Mother had lived.

Gail was not close to being done tormenting Mother. About a year later, she gave an order that praised jsh for being kind and loving with her mother. WTF? Did judge gail NOT know about how jsh starved her mother and put her in a hospital for 6 weeks and what pain Mother was going through? Gail gave jsh unlimited time with Mother and could take mother anywhere she wanted to go. I doubt very much if jsh ever spent much time with Mother or ever took her anywhere because of jsh's hate of her mother. But, gail said I had psychological problems and needed to be evaluated by a psychologist. I agreed to it to prove I was NOT the problem, but gail refused to do it. Why did gail back down? Because I could prove to any psychologist about the mafia's scam on Mother. At most. Only for a while, I was only allowed 3, 1 hour visits with Mother per week. After that the visits were constantly being denied by gail and sterling for punishment.



About August 2023, corrupt judge Melissa Sterling was the next judge in the scam after corrupt judge Gail became a US district court judge. Sterling took over the guardian scam on Mother for about a year until my Mother, Jane, was killed/died. Mother was killed/died by this mafia on July 2, 2024. The mafia kept Mother unconscious with morphine. Mother died a very slow, painful, barbaric and inhumane death by dehydration and starvation because the mafia was done with her. Mother and other such victims of their greed were only disposable cargo to them, WITH a huge bank account. Sterling also revealed how corrupt she was. She refused to unblock my email addresses Gail/IT person blocked. Sterling claimed she needed to know the names of the people of the county who were helping me. BS! The IT person did NOT know THEIR names to block them. Sterling wanted to know their names to stop me from helping Mother go home. Sterling refused my emergency petition in September 2023 for the mafia to PROVE their claim I was a danger or menace to Mother because of their severe, unnatural and limiting visits with Mother. All of the sisters begged Sterling to deny my petition. Sterling ruled FOR them. Sterling also ruled FOR them to deny me using a cell phone to record my visits to PROVE I never said or did anything to make Mother "agitated". The mafia always used that made up word to deny me visits with Mother. The mafia wanted their paid liars (monitors) who had to sit with Mother and me during my visits. The monitors were told to make notes of what I said or did. They were told to write lies about me to be used by the mafia to restrict and deny me visits. They were hired by Pam Blumer, who took over from Logie in May 2022. Logie quit because I was always telling him how he was not taking care of Mother. I was being punished for something WITHOUT any actual proof or trial? A cell phone would prove if I said or did something wrong. The cell phone was my idea. The U.S. law says a person is presumed innocent until proven guilty in a court of law and a person has the RIGHT to face their accusers. Did NONE of all of those judges and sisters know that??? Of course, NO BODY ever asked Mother if I ever did anything to get her upset or mad as unknown people claimed I did. WTF? The mafia continued to use the word "agitating" without any proof I did.

There are tons of documents, court documents, pictures, videos, emails PROVING Mother's guardianship was only a scam for her money. As of August 2026, the matter is in probate. Most of those same crooks of the guardian mafia are still demanding more money. I have a lawyer fighting to stop them from getting more money, also my inheritance. For unknown reasons, Jsh is NOT fighting to keep that money from them. She would be getting 50% of the money saved by MY efforts and MY paid lawyer. Jsh also NEVER wanted to get Mother home to save money. The cost of the pig pen was about \$90,000 compared to the court accepted cost (by Gail) of Mother living at home was only \$16,500 per year. That included school tax, property tax, HOA, sewer tax and house insurance. Why would Jsh want 50% of her inheritance wasted on such an expensive pig pen for her Mother if Jsh actually loved her Mother as Jsh tried to claim. What loving daughter STAVES her 96 year old Mother to the point of Mother passing out? Because Jsh did not want Mother to live back home, after about

3 years, jsh lost about \$150,000 from inheritance. I also lost that same amount. Plus, all of those massive lawyer fees, the guardian fees and a "care manager" because of a fake, made up guardianship. I firmly believe jsh was getting a lot of kickbacks from the mafia under the table for going along with their scam on Mother AND against me because I was exposing their barbaric scam by gail/sterling/ mafia.

The real crime by the mafia was the time they denied Mother and me together. Out of a possible 24,700 hours I could have been with my Mother from august 25 2021 when she was kidnapped from her house by jsh and logie to July 2 2024, when Mother was reborn, based on 16 hour days (8 hours for sleeping), the mafia only allowed Mother and I only about 224 hours together. What a waste of a very kind and loving Mother's last 3 years of life.

Dear Mr. Weilheimer,

If you go to my massive news website [janeherring.net](http://janeherring.net), you will see a great deal of documents, court documents, orders, pictures, emails and videos about the guardian corruption on my late mother, Jane Herring. My other news website details the horror and pain of victims of guardianship corruption nationwide.

Since you work for a major newspaper, you are aware that reporters must have documentation for their stories. My website, [janeherring.net](http://janeherring.net) has massive amounts of documentation of my Mother's three year horror she lived through by two very corrupt judges, corrupt guardians, corrupt lawyers, a corrupt "care manager", a corrupt psychologist, the corrupt lawyer assigned to my Mother by a judge and my own sister who had tried for years to take ownership of my Mother and her vast assets for my sister's own use. I always stopped those attempts by my sister and one of those corrupt lawyers.

On my Mother's website, you will see a great deal of information proving that two different judges were in charge of my Mother's extremely corrupt and never needed guardianship: Gail Weilheimer and Lisa Sterling.

Guardianship corruption has been massive in the Montgomery County court for over 30 years involving corrupt judges and others. On Facebook, a massive site about that guardianship corruption is called Shenanigans in the Montgomery County court. The site has been up for over 25 years. I am not involved with that site, but its author has posted many segments about me on it.

My Mother and I always had a extremely close and loving relationship. Every day I tried to help my Mother to get back home to her huge, beautiful home she lived in for 22 years. Mother was forced to live in a low rated nursing home, in a very tiny room, locked in solitary confinement, in a sensory deprived environment, no phone, no TV, no friends allowed. She was forced to be kept with with people with serious mental and behavior problems. There were men in her same locked in section, no locks on the doors and no cameras to see who went into the rooms during the night. Almost all of the people were women in Mother's section.

I spent over \$100,000 for lawyer fees and other costs to get Mother home. I was pro se most of the time and kept uncovering massive amounts of corruption and violation of federal laws, state laws, PA Rules of conduct for lawyers and the rules for the treatment of the AIP. I went to prison 5 different times, for almost 1.5 years for exposing the corruption by this "guardian mafia", specifically by the lawyer assigned to my Mother by Ms. Weilheimer. The petition was filed May 18, 2021 by my sister's lawyer, Camp. Ms. Weilheimer appointed the lawyer jaskowiak on May 21 2021. Mother and I were never notified of the petition until May 24 2021 by email. Mother had assets of about \$2 million to hire her own lawyer at 96, but was always denied to fire jaskowiak. My Mother had NO financial, medical, personal or mental problems to be guardianized by the first judge, Ms. Weilheimer. Ms. Weilheimer was in charge of my Mother for about 2.5 years. Sterling was in charge for the last 6 months.

Because I was constantly exposing this "guardian mafia" of my Mother, both judges used visits as weapons to severely restrict and mostly deny me one hour visits. I was constantly being accused of lies by this

mafia who refused to ever want to prove them in court. As you know as a lawyer, under the law, a person is presumed innocent until proven guilty in a court of law and they have the right to face their accusers. How can two judges and as many as seven lawyers fail to know that? Nationwide, guardians always make up lies about people who care about their loved ones. Those families prove the guardians are not doing their jobs taking care of their loved ones. Those corrupt guardians use those lies to deny visits to those loved ones.

Mother was kidnapped from her home on August 25 2021 by my sister and first guardian Logie. Out of a possible 24,700 possible hours I could have been with my Mother from August 25 2021 (16 hours awake, 8 hours sleeping), to July 2 2024 when she was killed/died at age 99, this combined mafia only allowed my Mother and I about 224 hours together. Mother was finally killed/died by being kept unconscious with morphine. Mother was killed/died a extremely slow, barbaric and inhumane death by dehydration and starvation. Mother was only disposable cargo for this mafia, with a large bank account. There are many, many more facts of this massive scam that are posted on the news website of Mother.

Myself and many others have gone through this guardianship corruption, in Montgomery and other nearby counties. Many times we have talked to reporters from the Inquirer to do stories about our cases for years. The families were interviewed, but the reporters told us their stories were killed because of your connection with the Inquirer and it involved your wife as a judge. Other judges, past and present, have also been involved in guardianship corruption in various counties. Many people have complained to DA Steele, but he and his detectives have refused to do anything. They claim the matter is civil, not criminal. The local FBI said the same thing. As a matter of fact, the local FBI had threatened me with arrest for trespassing if I ever showed up again to complain. Nobody involved with any crime wants the news media to put their picture and story about them for the public to see, especially very important people who are in public domain.

The news media cannot be corrupt by protecting and covering up criminal's crime as a favor to them because they are famous or a friend of a media type.

I would appreciate a response from you on this matter and hope the victims (alive or dead) and their families finally get justice from those guardian scams with a in-depth, detailed, expose by the Inquirer. All names of everyone, especially those in power, must be included. My documents, in my news website [janeherring.net](http://janeherring.net), prove what happened and who was involved in the scam on my Mother only for her money. Other news media, nationwide, including You Tube, have done detailed stories about guardianship corruption for years. About ten years ago, Netflix made a movie called "I Care a Lot" about guardianship corruption. Those corrupt guardians, corrupt lawyers and others can have 50, 100 or 1,000 other "clients" (victims). They can make millions of dollars each year by stealing from their victims, but ignoring those victims care and happiness. The Inquirer can help stop this inhumane, human trafficking (also called "white slavery") on the elderly and their loved ones.
