

U.S. DISTRICT COURT JUDGE BEETLESTONE

Corrupt judge weilheimer was appointed to the US District court in Philadelphia in mid 2023. She is best friends of lorie shapiro, wife of josh shapiro. Josh nominated corrupt gail to biden and biden appointed gail.

Corrupt judge gail was in charge of Mother's fake guardianship only to get Mother's vast assets for the guardian mafia. Jack ass jaskowiak was Mother's corrupt lawyer appointed by corrupt gail.

In August 2026, I sent a long letter and documents to judge Beetlestone and 10 other judges in the U.S district court exposing weilheimer as a corrupt judge and must be removed and disbarred.

Included in my documents to Beetlestone were 2 documents. One was a letter from corrupt gail where she says she is having the county IT person, Olivieri, block my email address to her office. But, the next day, Olivieri sent her office a email telling them he did what they told him to do and block my email address to ALL county agencies, including the sheriff, DA and board of commissioners. Corrupt gail committed many felonies. Corrupt gail was trying to stop me from using any county agencies to help my Mother get back home from the pig pen nursing home she was forced to live in by the guardian mafia, which included Mother's monster daughter: jsh. The guardian mafia forced Mother to live in a tiny room, in locked in solitary confinement, in a sensory deprived environment, no tv, no phone, and basically no friends allowed, including me.

It will be interesting what Beetlestone will do.

Dear Judge Beetlestone,

I am writing to you to inform you, as Chief Judge, about one of your new judges, Gail Weilheimer. Ms. Weilheimer was a former judge in Orphans Court of Montgomery County. She had been involved, for many years, in a large criminal organization that I have called a "guardian mafia". This "guardian mafia" consists of various types of people, who use fake guardianships to have people, usually very elderly, falsely declared "incapacitated" so the victim's assets and houses can be stolen by this mafia for themselves.

Montgomery County Orphans Court, including various judges past and present, has for many decades been well known for this type of guardian corruption. This "mafia" and others like it consist of corrupt judges, corrupt guardians, corrupt lawyers, corrupt psychologists and others. They work together to be able to have elderly people "owned" by the group. The scam usually starts because a family member files a petition to be in control of the victim (mother, father, grand parents, etc,) only for the victim's assets (money, house, property, etc.) before the person dies just to spend on themselves. Without the petitioner knowing it, the mafia will take over to steal from the victim. The corrupt judge assigns a corrupt lawyer to the victim to be sure all decisions go for the benefit of this mafia. Then the judge hires a corrupt psychologist who claims they gave the person a "evaluation" and declares the person "100% incapacitated". In a hearing, the judge will declare the person incapacitated and assigns its own guardians of person and estate to do what the mafia wants, including hiring their friends, other lawyers, "care managers", etc, and charge all of those costs (travel time, gas, etc) to the victim. The mafia just lists various charges without any receipts for those charges. Many lawyers are hired by the mafia and charge the victim those massive costs. If a family member criticizes anyone in the mafia for neglecting the care of the loved one, then the guardians will make up lies about the person to deny or severely restrict visits with the victim. The judge will always deny any attempt to fire the guardians or anyone in this mafia and will always deny any Motions or Petitions by the family or their lawyers to help their loved one get better care. The judge will ignore the federal and state laws, the PA Rules of Conduct for lawyers and the Rules of how the guardians and any lawyer are supposed to follow for the victim. The fact is, the victim has many rights, including the right to be in court at all proceedings and has the right to make almost all decisions for themselves and the guardians must do the most to fulfill those wants by the victim. There is NO law nationwide that limits the number of victims a guardian can have. That number can be 25, 50 or 5,000. If a mafia member is a guardian of estate, the amount of money any mafia can have for themselves can be in the many millions. There is NO law that says the victims's lawyer or any guardian has to provide proof that they ever saw the victim, but can claim they spent hours with the victim every week just for the money.

What I have just described is exactly what Judge Weilheimer was involved in. Ms. Weilheimer was in charge of my Mother, Jane Herring, for 2 out of 3 years Mother was in guardianship. Mother had NO problems in her daily activities, NO medical, mental, behavior or financial problems to be guardianized. Mother owned her large house for 22 years, still drove her car safely, her bills were auto paid and her money was handled by a investment company. I had dinner with Mother every day for about 8 years after my Father died and I lived with Mother (at her request) for 2 years before the fake petition was filed. The corrupt psychologist the mafia used admitted he had NO proof of accuracy for the tests he claimed he gave my Mother and NO proof of accuracy for his "evaluation" he wrote about Mother. Ms. Weilheimer's appointed lawyers and guardians to Mother. They always refused to allow Mother to come to court to speak for herself. The law demands it. Mother's nightmare started in August 2021 when she was 96 and only ended because she was killed/died at

99 in July 2024. The mafia kept Mother unconscious by morphine. Mother died a very slow, painful and barbaric death of dehydration and starvation. There are other judges in Orphans Court today that are doing the same thing. My sister, Jsh, (age 70) was the one who filed the petition to "own" Mother's assets of about \$2 million. Jsh dropped out because I was going to expose her and a soon to be guardian of estate of trying to steal Mother's money for years. I always stopped them. Mother and I were always very close and loved each other very much.

I created my news website janeherring.net with documents, court documents, pictures, emails, etc to prove Mother's "guardianship" was always a scam for Mother's money. For 3 years, Mother was kept in a low rated nursing home, in solitary confinement, in a sensory deprived environment, no phone, no TV, basically no visits allowed to Mother and me by Ms. Weilheimer/mafia because I was constantly exposing them on weekly radio shows, protesting in front of the court, attending various county meetings, meetings with the DA, FBI, etc. DA Steele and the FBI refused to open any criminal cases on Mother and the many other people whose loved ones were also in fake guardianships. They called them civil matters, not criminal. Look up the name Gloria Byers of Delaware county and see what happened to her by the local DA, DOJ, FBI and the IRS. I filed many, many petitions and Motions, but they were always denied by Ms. Weilheimer and later judge Sterling, who took over the mafia after Ms. Weilheimer left. The mafia was always making up lies about me to deny me visits with Mother, but they refused to use the court to prove any of them. That is called lawfare. I was pro se for most of that time because I had spent all of my money for lawyers to get Mother home. I had to live in my car and was on welfare. My background was 41 years doing lie detection testing and training worldwide.

In June 2023, Ms. Weilheimer sent me a email (enclosed). She claimed she was having the county IT, Olivieri, block my email address to her office because she claimed I was asking too many questions of procedure of her staff. But, she lied. By accident, Olivieri sent me the same email (enclosed) he sent to Ms. Weilheimer's legal assistant stating he did what Weilheimer wanted and blocked my email address to all county agencies, including the DA, Board of Commissioners and the sheriff because Weilheimer wanted to try to stop those agencies from helping me and my Mother. To this day, my email is still blocked to all of them. Judge Sterling REFUSED to have Olivieri unblock my email address. Even my court docket was blocked so I could not see it. The Register of Wills had to print out court documents for me to pick up each week. What Ms. Weilheimer did is illegal in many ways. She never had the power to block my email address. Both Ms. Weilheimer and Sterling did many things to "punish" me, including keeping Mother and me from being together because I was exposing their criminal activities. I was put into prison 5 times by the lawyer, Jaskowiak Weilheimer appointed for my Mother because I was exposing their scam. Again, that is called lawfare.

Have you or anyone ever seen any stories in the Philadelphia Inquire about the corruption of Ms. Weilheimer and the other judges in Orphans Court in Norristown? No, because the vice president and chief council of the paper is Larry Weilheimer, Gail's husband. He bans all stories about it, even now, because those stories would embarrass his wife and her close friends: Lorie Shapiro whose husband Josh nominated Ms. Weilheimer to Biden and Biden appointed Ms. Weilheimer. So much for freedom of the press.

Action must be taken, beginning with you, to remove any corrupt judge in the U.S. District court. The public deserves to have only honest judges deciding the public's cases. I and my website are always available to anyone to help prosecute and convict those criminals who thought my Mother and other victims were only disposable cargo, who had bank accounts and houses for their private use.
