On August 26 2026, I sent a packet of documents to Bartorilla proving police chief clowser • (New Britain) was protecting a dirty cop, komatick, who was involved in a clear, false arrest of me for simply protesting on a public sidewalk in front of jaskowiak's house in April 2024.. The arrest was started by a corrupt shister, david jaskowiak, who was appointed by a corrupt judge: gail weilheimer, in Montgomery county. Weilheimer was in charge of the fake guardianship just for my Mother's vast assets.

Clowser has refused to open an investigation on my false arrest by komatick and jaskowiak's part in it. Why?

I also sent my packets to the 3 vice presidents of the Bucks County Police Chief Association. What will all of them do about a dirty police chief protecting a dirty cop and the felonies that go along with it?

Dear Chief Bartorilla,

I am contacting you because of a extremely serious situation pertaining to New Britain Police and its Chief: Chief Clowser. This matter involves the corruption of Chief Clowser and a former(?) police officer: Alex Komatic. Action, of all types needed, must be taken by the Association to protect the public from a corrupt police chief.

My late Mother, Jane Herring, was a victim from 2021-2024 (age 96-99) of a guardianship scam, by a "guardian mafia" in the Orphans Court in Montgomery County. This "guardian mafia" involved her daughter (age 70), several corrupt judges, corrupt guardians, corrupt lawyers, a corrupt psychologist, a corrupt DA and others. Guardianship corruption involves a close family member who wants to have their parent, grandparent, etc, assets now to spend, instead of waiting for that person to die. Those people involved in Mother's scam stole hundreds of thousands of dollars from her, while keeping Mother a prisoner in a low rated nursing home, in solitary confinement, in a sensory deprived environment, no phone, no tv and basically no visits allowed to me with Mother. Mother had NO medical, NO mental and NO financial problems to be guardianized at age 96. Mother was "guardianized" by this "guardian mafia" for 3 years until she was killed/died by morphine. Mother was kept unconscious, where she died a extremely slow, painfull, barbaric and inhumane death by starvation and dehydration.

My background was a 41 year career doing lie detection testing and training worldwide. I used the only proven system of Voice Stress Analysis: PSE. I used that experience to get the facts, documents, court documents, transcripts, pictures, emails, videos, etc, to prove how Mother was a victim of a fake scam just for her vast assets. I was put into prison 5 times by Mother's court appointed lawyer, David Jaskowiak, because I was exposing Jaskowiak and others deep involvement in the scam. I did so in print, in my news websites and on nationwide radio shows. I was forced to serve almost 1.5 years in prison for exposing the scam, all because of Jaskowiak. Jaskowiak and others were/are doing the same thing to many hundreds of other elderly people.

Jaskowiak lives in New Britain township. On April 10, 2024, I handed out my 2 page newsletter to various neighbors telling them about Jaskowiak and others stealing from my Mother. On April 23 2024 I tried to protest in front of jaskowiak's house, but was chased away by an off- duty state police officer who claimed the sidewalk was private property and threatened me with arrest if I stayed. I went to New Britain police and the code officer told me it was a public sidewalk. As I was leaving, I met Alex Komatick and spent about 20 minutes telling him why I was protesting about the scam on Mother by Jaskowiak and others. On April 27, 2024, 9am, I began to protest again, on the public sidewalk, in silence, in front of Jaskowiak's house. Within minutes, 2 police cars showed up. One of the officers was Komatick. Komatick kept telling me some of the neighbors were upset by me protesting. I told him many times protesting is legal and protected by the Constitution. I videotaped the entire 2 hours to prove it was a legal protest. Both Komatick and jaskowiak were outside, on their cell phones the entire time. Who were they talking to? At 11am, Komatick arrested me. He lied many times in his affidavit, including what my protest sign said, what I wrote on the sidewalk and that I had no reason to be protesting there (all enclosed). Giving a false affidavit to law enforcement and manufacturing evidence are felonies. I was charged with 2 counts of harassment. Bail was \$100,000. Both Komatick and

Jaskowiak lied (perjury) twice during 2 court hearings (felonies). I had a public defender who refused to let me take the stand to testify, refused to show how Komatick and Jaskowiak lied and refused to ask my many questions proving it was a false arrest. I finally got bail reduced to \$10,000 and was released.

During most of the time of Mother's scam, I was pro se. When I got out after several months, I found that Jaskowiak and another lawyer in the scam, Ronald Fenstermacher, were sending time sensitive documents to a wrong address, so I would not see them so they would have decisions go their way against me. I told them to stop. Jaskowiak got the judge to put me back in prison. I got out after several months. About January 2025, I started to send letters to lawyers looking for a lawyer to sue them and others. Jaskowiak convinced the judge to put me back in prison for 8 months based on lies he made up at that trial. I was not allowed to say how Jaskowiak lied at this trial.

While I was in prison in summer 2025, I had a friend send packets of documents proving it was a false arrest to Chief Clowser, former DA Schorn (3 times), Judge McHugh, director of parole Shenk, New Britain board of supervisors. None of them responded. Why? When I left prison in January 2026, I sent packets to DA Khan, new board of supervisors, director of parole Harrison and New Britain township manager Valla. None of them responded. Why? Why didn't any of them care that a innocent person was in prison for a made up and bizaar claim of harassment for only protesting, a right guaranteed by the Constitution? While in prison, a friend tried to get a meeting several times with Clowser about Komatick and Jaskowiak, but Clowser refused. Why?

Why didn't Clowser want to correct a corrupt cop and Jaskowiak's lies that put me into prison for about a year? Why didn't Clowser care about any other probable arrests that Komatick made that were false and manufactured? How many of those fake arrests were made by him? How many fake traffic tickets were written by Komatick on innocent drivers? According to information, Komatick is no longer at New Britain police. Where did he go? Did Clowser do the usual and give Komatick the choice of quitting with a good reference or be fired if he refused to leave? What was the payoff to Komatick by Jaskowiak for lying in his affidavit and committing perjury twice in court? Money? A much better paying job as a cop with a bigger police department, etc?

About Spring 2026, Clowser and Valla sent me emails telling me they would not get involved and to go to DA Khan. Their emails are posted on janeherring.net. As I had said, Khan got my packet in about February 2026, but he has refused to respond. Why?

What will your Association do about this matter? Ignore it like those others are doing? Pretend I made it up? My documents and pictures prove who the real liars were. The emails from Clowser and Valla and "0" responses from the New Britain Board of Supervisors prove they do not care about a corrupt police chief and a corrupt police department.

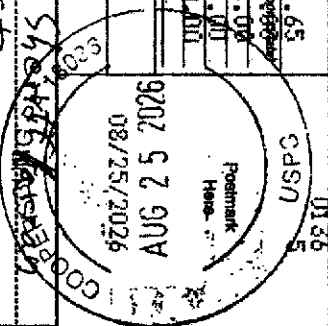
