

KHAN, BUCKS COUNTY DA, STILL REFUSES TO PROSECUTE POLICE FOR FALSE ARREST

DA Khan got a letter and my packet of documents and pictures from me in March 2026 proving my arrest by dirty cop Komatick of New Britain police and shister David "jack ass" jaskowiak in April 2024 was TOTALLY false. As of September 2026, Khan STILL has refused to reply to it. In addition, the dirty police chief, clowser, who also got the same packet of documents, pictures and also a email from me about my false arrest by komatick, also has refused to open a investigation on his dirty cop komatick. Why. Also, New Britain Board of Supervisors got the same packet in 2025 and early 2026 has decided they do not care if their police chief and police department are dirty. Why?

As was explained in previous documents, my false arrest was simply protesting on a public sidewalk in front of jack ass's house on April 27 2024. I was exposing jack ass's and other's (guardian mafia) involvement in a guardianship fraud on my late Mother, at 96 -99, when Mother was killed/died by this mafia. Dirty cop komatick/jack ass claimed it was 2 counts of harassment and jack ass went along with those fake charges because it meant prison time for me, AGAIN, by jack ass. Jack ass put me into prion 5 different times for exposing jack ass and others (guardian mafia) guardianship fraud for her vast assets.

That packet of documents and pictures PROVED the dirty cop komatick lied many times in his fake affidavit (felonies) and he and jack ass BOTH claimed the affidavit was truthfull in court 2 different times. That is called perjury and is a extremely serious crime. Jack ass, a lawyer, is also a officer of the court. Jack ass lied 2 different times in front of the president judge of Bucks County. Not smart, but that judge let jack ass get away with lying those 2 times. Why? Pay off?

On September 1 2026, I sent the same packet to Khan again. Khan constantly makes sure he gets his name in the paper when he prosecutes a person for a crime. So, why doesn't he care about a dirty cop, dirty police chief and a dirty shister making up a crime and using the court as a weapon on a innocent person?

Dear Mr. Khan,

I contacted you and the new director of parole Harrison, certified mail, on March 1, 2026 about my false arrest by the New Britain police on April 27 2024 for protesting, on a public sidewalk, in silence, in front of a lawyer's house. I have included that letter and other documents I had sent to you and Harrison on March 1 2026. I never received any response from you or Mr. Harrison. Why? I had also sent packets of documents, like this one, to judge McHugh, New Britain police chief Clowser, 2 different Board of Supervisors in 2025 and 2026, prosecutor McCartney, former DA Schorn (3 times). No responses from them either. Why? For some, I had a friend send them while I was in prison from May 23 2025 to January 2026 on a made up parole violation. I served 8 months for that made up parole violation.

In this letter to you now, I have again included the fake affidavit by the corrupt cop, Komatick, again included my explanations of basically each paragraph in Komatick's fake affidavit, again pictures of what was on my protest sign, again what I had written on the public sidewalk and again my letter sent to prosecutor McCartney I sent him (certified mail) from prison on 9/2/2025.

For more about the massive guardianship scam (August 2021-July 2 2024) on my now late Mother (age 96-99) only for her \$2 million in assets, which was the reason why I was protesting in front of that lawyer's (David Jaskowiak) house, go to my news website janeherring.net that proves that the fake guardianship on Mother was by a "guardian mafia" and Jaskowiak seemed to be in charge of it, along with corrupt judges, corrupt guardians, corrupt lawyers, a corrupt psychologist and my sister, jsh, who started the fake petition for guardianship on my Mother only for Mother's vast assets and Mother's house. On that news website, you can also see the full 2 hour video of me protesting made by me. It was a 100% legal protest.

When Komatick's fake affidavit is compared to my explanations of it, my picture of my sign and sidewalk and my video I made that day, there is no doubt that Komatick totally lied in his affidavit and he and Jaskowiak lied twice in 2 separate court hearings. That is called perjury and are crimes. Submitting a false affidavit to law enforcement is also a crime. As a matter of fact, at a court hearing on May 23 2025 on a fake parole violation for sending letters to lawyers looking for a lawyer to sue, Jaskowiak was allowed to give a "victims speech". He lied 3 times in it. When I asked judge McHugh to let me respond because Jaskowiak lied in his victim's speech, McHugh said no. Why? Prosecutor McCartney stood there and he did not care that Jaskowiak lied. Why? My parole officer was standing next to me. He also did not care Jaskowiak lied. Why? Judge McHugh did not care Jaskowiak, a officer of the court, had lied. Why?

I recently read in an article that you said that those students who protested from a high school were simply protesting. That was all I was doing and my documents and video prove it. I spent a total of 1 year in prison for that false arrest. Komatick lied only as a favor to Jaskowiak. What was Komatick's pay off for lying? I found out that about a year ago, Komatick is not with New Britain police. Where did he go? How many other false arrests did he make up? How many people got traffic tickets they did not deserve?

About 2 months ago, I went to a New Britain Board of Supervisor meeting. I met Clowser. He refused to do anything about my false arrest, as did the board and Valla, the new township manager. Why did none of them care about a corrupt police chief and a corrupt police department?

Will you now open a criminal investigation on this police corruption and my false arrest to correct what happened to me?
